#### ENTRY GUIDELINES FOR THE ART SHOW

ENTRY FORM DEADLINE: March 15, 2024 (Artwork delivery, see below.)

**ENTRY FEE:** \$35 for up to 4 pieces of artwork. Fee is due at the time of registration.

All applicants must be at least 18 years of age.

**Online Registration:** Go to: <u>TIM Show online registration</u>. **or,** print and mail or deliver the forms to the gallery.

**ART DROP-OFF/CHECK-IN:** Art to be dropped off at MIVAL Gallery, 2836 78th Ave SE, on Sunday (Easter), March 31st from 11:00 AM to 3:00 PM, or Monday, April 1st, 9:30 AM to noon.

**ART PICK-UP:** All unsold artworks must be picked up on Saturday, June 1st, 2:00 - 5:00 PM unless prior arrangements have been made. Neither MIVAL nor Avellino are responsible for art work not picked up on time.

#### **DIMENSIONS & CRITERIA:**

**Size for 2D** artworks: 8.5" x 8.5" or less including frame, **OR** 8.5" maximum in any direction including frame. The piece does <u>not</u> need to be square. Art must be wired and finished, ready to display and sell. Original work only. No Giclée prints will be accepted.

**Size for 3D** artworks: 6" x 6" x 6" or less. 6" maximum in any direction.

Art mediums for acceptance can include paint, textiles, gouache, glass, metal, photography, ink, and pencil. Art can be applied to paper, board, fabric, ceramics, etc. This includes any application of medium and technique. All pieces submitted to the show must be original and for sale and not previously shown in this venue. Prices will be determined by the artist. A Commission of 25% of all art sales will be retained.

Display and placement of art is at the discretion of the MIVAL Treasures In Miniature Show display committee. MIVAL reserves the right to refuse artwork that is deemed inappropriate, does not comply with the prospectus or meet our requirements for display. All art must be appropriate for all audiences. 2D art must be dry, securely framed, properly finished, ready to hang with wire securely attached. All art must be suitably framed for hanging on a nail or set on a small easel.

#### JPEG DEADLINE FOR MARKETING

If you wish to have your artwork considered for marketing materials (optional), jpegs of your art must be submitted no later than March 13th to Judith Roan at <a href="mailto:iroan@fredhutch.org">iroan@fredhutch.org</a>.
